The original Transfer of Land as well as, all applicable affidavits and an electronic on-line Document Registration Request (DRR) form; Logon to SPIN 2, <a href="www.spin.gov.ab.ca">www.spin.gov.ab.ca</a>, then click the DRR button on the SPIN 2 Menu Bar, see DRR Help files for additional information.

### **NOTE:**

- The Dower Affidavit **OR** Consent of Spouse **AND** Certificate of Acknowledgement by Spouse must be completed if there is "only" one transferor (current owner) on title.
- Clauses #2 AND #3 of the Affidavit Re Value of Land must be completed.

If attending the Land Titles Office and swearing an affidavit before a Land Titles Commissioner for Oaths, you must produce proper identification (e.g., a valid driver's license, passport or an identification card issued by Alberta Registries).
